

# Guidelines for "Research Fellowship Scheme for Ph.D. students-2023"

#### 1. Introduction:

- a) To promote research in State, Hon'ble Chief Minister has announced Research fellowship scheme for Ph.D. students of Government colleges of the State who have passed NET/SLET but are not receiving any kind of fellowship. These research scholars will be given a fellowship of Rs 20,000 per month for a maximum of 2 years for research work. Such research scholars will be taken as interns for effective implementation of public welfare schemes.
- b) This scheme will open new horizons for youths who wish to pursue higher studies such as regular and full time Ph.D. degrees in Sciences, Humanities, Social Sciences, Liberal Arts, Commerce in Government Colleges and State Government funded Universities (except Medical Educational Universities).

### 2. Objective:

- a) To provide 2 year fellowships in the form of financial assistance to research scholars of Government Colleges and all State Government funded Universities (except medical education universities).
- b) To create and promote quality research in State.
- e) To make research scholars self-reliant.
- d) To assist as an intern with regards to effective implementation of public welfare scheme of the state.

# 3. Eligibility criterion:

a) NET/SLET qualified registered Ph.D. research scholars of all State Government funded Universities (except medical education universities), and Government Colleges, Department of Higher Education who are not receiving any Government fellowship during the same period.


b) Number of research scholars who will be provided financial assistance under the scheme will be limited to 2200 research scholars for each academic year.

4. Duration of fellowship:

- Maximum duration of fellowship will be twenty-four months, but fellowship will not be provided after the date of thesis submission.
- b) For existing registered Ph.D. research scholars, period already spent before the date of application will be deducted from 24 months.
- c) Commencement of fellowship will be considered from the date of application.
- d) Fellowship of Rs 20000 per month will be provided to the Ph.D. research scholars who have qualified NET/SLET (not receiving JRF or any other fellowship).
- 5. Application procedure and disbursement of fellowship:
- a) Research scholars will register themselves for receiving fellowship through "Research Fellowship Scheme for Ph.D. students 2023" at the Portal/online mode of application initiated by the Department of Higher Education, Government of Rajasthan. Guide/Supervisor will verify the application of Ph.D. research scholar on priority basis within 15 days and will forward it to Principal/HoD (in case of University) for onward submission to Commissionerate College Education.
- b) Only verified online applications as mentioned above shall be considered for disbursement of fellowship amount within 30 days of time.
- c) Release of the fellowship to student's accounts will be based upon the submission of continuation certificate forwarded by supervisor/Principal of the College/ HoD (in case of University).
- d) College will withdraw the necessary fellowship amount from the relevant budget head for disbursement to the research scholar account. Bills will be prepared using Pay Manager and payment will be done through treasury.
- e) For required budgetary support State Government funded Universities shall submit their proposal to Commissionerate College Education under this scheme separately through administrative department on portal/online mode. Budget will be transferred in the PD account of the University accordingly. Disbursement to research scholars at Universities will be done by respective University through PD account and treasury.
- 1) In case of transfer of supervisor/guide, fellowship will be released on the recommendation of Co-Guide/IQAC Convener/Head of Department.
- g) Research scholars have to acknowledge the fellowship in their publications as well in the thesis while submitting their research work.

Guidelines for financial support to Research Scholars for participation in seminars, workshops, and conferences

#### 1. Introduction:

a) To promote and facilitate research in the state, Hon'ble Chief Minister has announced that "Research scholars studying in Government Colleges and Universities will be given financial assistance of up to Rs.25,000 for participation in seminars, workshops, and conferences in prestigious higher educational institutions and research institutions of the country". This scheme is expected to broaden the knowledge domain, cross pollination of ideas, networking, and career advancement along with collaboration and learning opportunities for Ph.D. research scholars at prestigious higher educational institutions and research institutions of the country.

2. Eligibility Criterion:

- a) Only registered Ph.D. research scholars of Government Colleges and all State Government funded Universities (except medical education universities) shall be eligible for financial assistance of up to Rs.25,000 for participation in seminars, workshops, and conferences in prestigious higher educational institutions and research institutions (as per Annexure A) of the country.
- b) No financial support will be given, if any seminar, workshop, and conference are held at the parent institution of the research scholar
- c) Number of research scholars who will be provided financial assistance under the scheme will be limited to 3800 research scholars for an academic year

3. Application Procedure and disbursement:

- a) Research scholar shall apply in the prescribed format to the Principal of the Government College/HoD of the State Government funded University for seeking assistance.
- b) The application submitted above will be marked to respective supervisor/guide and it will be decided within a period of seven working days. Supervisor/Guide in general will grant permission to the scholar, however in exceptional cases application by recording teachers. In cases where Principal/HoD (University) has not forwarded the application for participation then in any case it will be deemed approved after lapse of 15 working days from the date of application to Principal/HoD (University). However, it will also be seen that there is no foul play on the part of research scholar.

- e) Registration charges, accommodation, travel fair, poster preparation, food expenses (incurred in respect of seminars, workshops, and conferences) will be reimbursed.
- d) Actual travel fare by any mode of transport, will be reimbursed to Ph.D. research scholar (to & fro) from the College/University to designated institution (Annexure A), after submission of tickets to Principal of College/HoD of University subject to the limit of Rs 25000 (Rs Twenty five thousand) for all the expenses incurred for participation in seminars, workshops, and conferences.
- e) After producing the bills/claims verified by the supervisor in the prescribed format along with participation certificate to the Principal of the College/HoD of the University, the College/University will reimburse the expenses in the research scholar account.
- f) College will withdraw the necessary amount from the relevant budget head for disbursement to the research scholar account. Bills will be prepared using Pay Manager and payment will be done through treasury.
- g) For required budgetary support State Government funded Universities shall submit their proposal to Commissionerate College Education under this scheme separately through administrative department on portal/online mode. Budget will be transferred in the PD account of the University accordingly. Disbursement to research scholars at Universities will be done by respective University through PD account and treasury.
- h) Subsequent participation in seminars, workshops, and conferences will be based on the earlier report submitted by the research scholar to his/her supervisor
- i) The upper limit of financial assistance to any research scholar will not exceed Rs 25000 (Rs Twenty five thousand) for participation in seminars, workshops, and conferences in an academic year ( I" July-30th June).
- j) If a Ph.D. research scholar receives partly financial assistance for a seminar, workshop, or conference from any other organization, then scholar will be given gap funding for the admissible expenditure for the remaining part of the event up to a maximum of Rs. 25,000 each academic
