**THE RAJIV GANDHI TRIBAL UNIVERSITY, UDAIPUR  
(CHANGE OF NAME AND HEADQUARTERS, AND  
AMENDMENT) ACT, 2016**

(Act No. 10 of 2016)

[Received the assent of the Governor on the 18<sup>th</sup> day of April, 2016]

*Act*

*to change the name of the Rajiv Gandhi Tribal University, Udaipur and its headquarters and also to make certain amendments in the Rajiv Gandhi Tribal University, Udaipur Act, 2012.*

Be it enacted by the Rajasthan State Legislature in the Sixty-seventh Year of the Republic of India, as follows:-

**1. Short title and commencement.-** (1) This Act may be called the Rajiv Gandhi Tribal University, Udaipur (Change of Name and Headquarters, and Amendment) Act, 2016.

(2) It shall come into force on and from 1<sup>st</sup> July, 2016.

**2. Change of name of the Rajiv Gandhi Tribal University, Udaipur.-** (1) The name of the Rajiv Gandhi Tribal University, Udaipur incorporated under the Rajiv Gandhi Tribal University, Udaipur Act, 2012 (Act No. 31 of 2012), hereinafter referred to as the principal Act, shall, as from the date of commencement of this Act, be the Govind Guru Tribal University, Banswara.

(2) Any reference to the Rajiv Gandhi Tribal University, Udaipur in any law for the time being in force or in any indenture, instrument or other documents shall be read and construed as a reference to that University under its name as altered by this Act.

(3) Nothing in this Act shall affect the continuity of the corporate status of the said University.

**3. Citation of the principal Act.-** The principal Act may be cited as the Govind Guru Tribal University, Banswara Act, 2012.

**4. Amendment of Long Title, Rajasthan Act No. 31 of 2012.-** In long title of the principal Act, for the existing expression

"Rajiv Gandhi Tribal University at Udaipur", the expression "Govind Guru Tribal University at Banswara" shall be substituted.

**5. Amendment of section 1, Rajasthan Act No. 31 of 2012.-** In sub-section (1) of section 1 of the principal Act, for the existing expression "the Rajiv Gandhi Tribal University, Udaipur", the expression "the Govind Guru Tribal University, Banswara" shall be substituted.

**6. Amendment of section 2, Rajasthan Act No. 31 of 2012.-** In section 2 of the principal Act,-

(i) after the existing clause (b) and before existing clause (c), the following new clauses shall be inserted, namely:-

"(bb) "affiliated college" means an educational institution admitted to the privileges of the University;

(bbb) "autonomous college" means an educational institution declared as such under the provisions of this Act;"

(ii) after the existing clause (d) and before existing clause (e), the following new clause shall be inserted, namely:-

"(dd) "constituent college" means a college maintained by the University;"

(iii) after the existing clause (g) and before existing clause (h), the following new clause shall be inserted, namely:-

"(gg) "Principal" means the Chief Executive Officer of a college or any person duly appointed to act as such;" and

(iv) for the existing clause (m), the following shall be substituted, namely:-

"(m) "University" means the Govind Guru Tribal University, Banswara incorporated under section 3;"

**7. Amendment of section 3, Rajasthan Act No. 31 of 2012.-** In section 3 of the principal Act,-

(i) in sub-section (1), for the existing expression "the Rajiv Gandhi Tribal University, Udaipur", the expression "the Govind Guru Tribal University, Banswara" shall be substituted; and

(ii) for the existing sub-section (3), the following shall be substituted, namely:-

"(3) The headquarters of the University shall be at Banswara which shall be the headquarters of the Vice-Chancellor."

**8. Amendment of section 4, Rajasthan Act No. 31 of 2012.**- For the existing section 4 of the principal Act, the following shall be substituted, namely:-

**"4. Jurisdiction.**- (1) Notwithstanding anything contained in any law for the time being in force but subject to the provisions of the University of Rajasthan Act, 1946, the Swami Keshwanand Rajasthan Agriculture University, Bikaner Act, 1987 (Act No. 39 of 1987), the Jagadguru Ramanandacharya Rajasthan Sanskrit University Act, 1998 (Act No. 10 of 1998), the Maharana Pratap University of Agriculture and Technology Udaipur Act, 2000 (Act No. 8 of 2000), the Dr. Sarvepalli Radhakrishnan Rajasthan Ayurved University, Jodhpur Act, 2002 (Act No. 15 of 2002), the Rajasthan University of Health Sciences Act, 2005 (Act No. 1 of 2005) and the Rajasthan Technical University Act, 2006 (Act No. 8 of 2006), the jurisdiction of the University shall extend to all the constituent, affiliated or autonomous colleges and to such other colleges, institutes, institutions and departments within the State of Rajasthan as may be specified by notification in the Official Gazette by the State Government.

(2) The State Government may, by order in writing,-

- (a) require any institute, institution or college within the State to terminate with effect from such date as may be specified in the order, its association with, or its admission to the privileges of any other University incorporated by law to such extent as may be considered necessary and proper, or
- (b) exclude, to such extent as may be considered necessary and proper, from association with, or from admission to

the privileges of the University constituted by this Act any institute, institution or college specified in the order which, in the opinion of the State Government is required to be self governing or to be associated with or admitted to the privileges of, any other University or body.

(3) The State Government may, in consultation with the University, by notification published in the Official Gazette, enumerate any Government College situated in the jurisdiction of the University to be a constituent college of the University. The land, buildings, laboratories, equipments, books and any other properties of such college shall then vest in the University and the officers, teachers and employees of such Government Colleges under the administrative control, after being found suitable, through screening and on fulfilling such terms and conditions as may be laid down in the notification, shall be deemed to be the officers, teachers or, as the case may be, employees of the University."

**9. Amendment of section 5, Rajasthan Act No. 31 of 2012.**- In section 5 of the principal Act,-

- (i) in clause (v), the existing word "and" appearing at the end, shall be deleted;
- (ii) in clause (vi), for the existing punctuation mark "." appearing at the end, the punctuation mark ";" shall be substituted; and
- (iii) *after clause (vi), so amended, the following new clauses shall be added, namely:-*
  - "(i) to make provision for imparting education in different branches of learning; and*
  - (ii) to further the prosecution of research in all branches of learning."*

**10. Amendment of section 7, Rajasthan Act No. 31 of 2012.**- In section 7 of the principal Act,-

- (i) in clause (v), the existing word "and" appearing at the end, shall be deleted;

- (ii) in clause (w), for the existing punctuation mark " ." appearing at the end, the punctuation mark " ; " shall be substituted; and
- (iii) after clause (w), so amended, the following new clauses shall be added, namely:-
  - "(x) to admit colleges, institutions and institutes not maintained by the University, to the privileges of the University, and to withdraw all or any of these privileges;
  - (y) to confer autonomous status on a college, institution or department, as the case may be, subject to such conditions as may be laid down in this Act or as may be prescribed by the Statutes and to withdraw the autonomy; and
  - (z) to cooperate with other University and authorities in such manner and for such purpose as the University may determine."

**11. Amendment of section 22, Rajasthan Act No. 31 of 2012.** - In sub-section (1) of section 22 of the principal Act,-

- (i) in sub-clause (vii) of clause (II), the existing word "and" appearing at the end, shall be deleted;
- (ii) in sub-clause (viii) of clause (II), for the existing punctuation mark " ." appearing at the end, the expression " ; and " shall be substituted; and
- (iii) after sub-clause (viii) of clause (II), so amended, the following new sub-clause shall be added, namely:-
  - "(ix) the Director/Commissioner of College Education, Rajasthan.";
- (iv) in sub-clause (iv) of clause (III), the existing word "and" appearing at the end, shall be deleted;
- (v) in sub-clause (v) of clause (III), for the existing punctuation mark " ." appearing at the end, the expression " ; and " shall be substituted; and
- (vi) after sub-clause (v) of clause (III), so amended, the following new sub-clause shall be added, namely:-
  - "(vi) two Principals of affiliated colleges, one from the Government Colleges and



another from Private Colleges, to be nominated by the State Government for one year."

**12. Amendment of section 24, Rajasthan Act No. 31 of 2012.**- In sub-section (1) of section 24 of the principal Act,-

- (i) in clause (h), the existing word "and" appearing at the end, shall be deleted;
- (ii) in clause (i), for the existing punctuation mark "." appearing at the end, the expression ";" shall be substituted; and
- (iii) after clause (i), so amended, the following new clauses shall be added, namely:-
  - (j) one Principal/Director of a constituent college to be nominated by the Vice-Chancellor;
  - (k) the Director/Commissioner of College Education, Rajasthan;
  - (l) two Principals of affiliated colleges, one from Government Colleges and another from Private Colleges, to be nominated by the State Government;
  - (m) one teacher other than the Professors, from a constituent college/University Department having a minimum ten years experience in teaching degree or post-graduate classes to be nominated by the Vice-Chancellor; and
  - (n) one teacher other than the Principals, from an affiliated college having a minimum ten years experience in teaching degree or post-graduate classes to be nominated by the State Government."

**13. Amendment of section 26, Rajasthan Act No. 31 of 2012.**- In sub-section (2) of section 26 of the principal Act,-

- (i) in clause (c), the existing word "and" appearing at the end, shall be deleted;
- (ii) in clause (d), for the existing punctuation mark "." appearing at the end, the expression "; and" shall be substituted; and
- (iii) after clause (d), so amended, the following new clause shall be added, namely:-

"(e) one Post-graduate College Principal and one Postgraduate Department Head in each subject of the Faculty from affiliated colleges, nominated by the State Government."

**14. Amendment of section 30, Rajasthan Act No. 31 of 2012.-** For the existing sub-section (1) of section 30 of the principal Act, the following shall be substituted, namely:-

"(1) All teaching recognized by the University shall be conducted in the University departments or in colleges, institutes and institutions."

**15. Insertion of new sections 33A and 33B, Rajasthan Act No. 31 of 2012.-** After the existing section 33 and before existing section 34 of the principal Act, the following new sections shall be inserted, namely:-

**"33A. Conferment of autonomous status.-** (1) An affiliated college or a recognized institution or a University Department may be conferred the autonomous status by the University in the matter of admission of students, prescribing the courses of studies, imparting instructions and training, holding of examinations and the powers to make necessary rules for the purpose.

(2) The Board shall for the purpose of satisfying itself about the standards of education in such a college, institution or department may direct an enquiry to be made in the prescribed manner by a standing committee consisting of such persons as are deemed fit.

(3) On receipt of the report of the said committee and the recommendations of the Academic Council thereon, the Board on being satisfied, shall refer the matter to the University Grants Commission and the State Government to obtain their concurrence.

(4) On receipt of such concurrence, the University shall confer the autonomous status on the college, the institution or the department, as the case may be.

(5) The status of autonomy may be granted initially for a period of five years subject to review by an expert committee to be constituted for this purpose. The committee shall comprise the following, namely:-

(a) one nominee of the University;

(b) one nominee of the State Government;



- (c) one nominee of the University Grants Commission;
- (d) one Principal of an autonomous college to be nominated by the Vice-Chancellor; and
- (e) an officer of the University to be nominated by the Vice-Chancellor.

(6) The Committee shall submit its report to the Board for further action.

(7) The University shall continue to exercise general supervision over such college, institution or department and to confer degrees on the students of such college, institution or department.

(8) The autonomous college, institution or department shall appoint such committees as may be prescribed for the proper management relating to academic, financial and administrative affairs.

(9) Every autonomous college, institution or department shall furnish such reports, returns and other information as the Board may require from time to time.

(10) The Board shall cause every autonomous college, institution or department to be inspected from time to time.

**33B. Withdrawal of autonomous status.-** (1) The conferment of autonomous status may be withdrawn by the University if the college, institution or department has failed to observe any of the conditions of its conferment or the efficiency thereof has so deteriorated that in the interest of education it is necessary to do so.

(2) Before an order under sub-section (1) is made, the Board shall, by one month's notice in writing, call upon the college, institution or department to show cause why such an order should not be made.

(3) On receipt of the explanation, if any, made by the college, institution or department in reply to the notice, the Board shall, after consulting the Academic Council and the University Grants Commission report the matter to the State Government.

(4) The State Government shall, after such further enquiry, if any, as may be deemed fit, record its opinion in the matter and convey its decision to the University and the University shall thereupon make such order as it deems fit.

(5) Where in the case of an autonomous college, institution or department, the autonomous status conferred under section 33A is withdrawn by an order made under subsection (4), such college, institution or department, as the case may be, shall cease to have an autonomous status from the date specified in the order."

**16. Insertion of new section 48A, Rajasthan Act No. 31 of 2012.** - After the existing section 48 and before existing section 49 of the principal Act, the following new section shall be inserted, namely:-

**"48A. Transfer of properties and manpower.** - Notwithstanding anything contained in any law for the time being in force, the Chancellor may, in order to give effect to the provisions of this Act, on the advice of the State Government, make such orders as are deemed necessary, for the transfer of-

- (a) any officer, teacher, employee or servant,
- (b) any movable or immovable property situated in the jurisdictional area of this University or any rights or interest therein, and
- (c) any fund, grant, contribution, donation, aid or benefaction received, accrued or promised,

from the Mohan Lal Sukhadia University, Udaipur or any other University to this University on such terms and conditions as may be specified in the orders."
